Dear Trader,

We are holding this outdoor event in a friendly family atmosphere situated in 98 beautiful acres of the Staffordshire countryside. The event is being held on the 23rd, 24th, 25th, & 26th of August 2019 at the Kibblestone Scout Camp, Kibblestone Road, Oulton, Stone, Staffordshire, ST15 8UJ

The event will provide an excellent opportunity for all traders to promote their products. Once your registration and payment has been received, your application to trade will be considered by the promoters. Upon acceptance your payment will be processed. You will be allocated a position on the site on arrival at the Artemis Gathering.

It is important to fill out the forms carefully summarising your products. Please ensure you return the form promptly as we cannot reserve any stalls without payment and a completed form, and please do not forget to **include a copy of your trading insurance**! We are asking that all stall traders donate a small prize to the raffle. If you are a full member of the Children Of Artemis you are entitled to a discount on the price of a stall – please be sure to include your membership number on the form.

Please note that each trader will be allocated a total space of 6m wide by 3m deep with a 6m x 3m wide space behind to park your vehicle and/or put up your tent. Larger spaces are by arrangement, so if you need more space please contact us before you book. Please note that tables, chairs & electricity are **NOT** provided. Dogs are welcome but must be kept on a leash at all times and all mess must cleared. Please remember to bring your own tent and camping equipment. The booking includes one vehicle, you will need to purchase a ticket for additional vehicles, please note unregistered vehicles will not be permitted on site.

The event will include a marquee with catering & bar facilities where you can purchase food & drink available for vegetarians, & omnivores. Talks and workshops will be held in buildings and marquees on site.

We anticipate the loading-in time for stallholders will be approximately 12.00pm on Friday 23rd of August.. Trading will start by 7pm Friday. Further details will be sent with your confirmation nearer the time, including: directions to the campsite. If you have any questions, please do not hesitate to contact us at the address or phone number above.

If your stall booking is accepted you will be sent a confirmation letter. Only traders who have received this confirmation have a booking, so please ensure you have your acceptance letter before attending the event. Please note that applications from traders with overdue payments on any Children of Artemis, Witchcraft & Wicca magazine, or Witchfest accounts will not be accepted. Cheques received for unsuccessful applications will be returned.

We hope you are looking forward to this event as much as we are and look forward to meeting you all there.

In such cases a full refund of booking / admission fee will be made. Trader's information -The Artemis Gathering 2019

- Traders must be set up no later than 7pm on Friday, you have access from midday on Friday, event opens to visitors Friday at 4.00pm.
- Tables, Tents & Chairs are not provided, please remember to bring your own. Your pitch consists of a 6m x 3m square of grass only, with a similar space behind for vehicles/camping. Any vehicles that cannot fit inside the allocated space must be parked in the adjacent carpark.
- Your booking includes only one vehicle, (car, van, or campervan), you may register extra vehicles on the form. Please contact us before the event for permission if you wish to bring a towed caravan, this must be done in advance.
- All cars/vans not parked in the allocated space behind the stalls must be removed from the trade area by 7pm Friday. After which time there will be no vehicular access. This rule must be strictly adhered to in order to comply with Health & Safety.
- Only registered vehicles will be permitted to enter the site.
- When the trade area is open, stands must be manned at all times by a responsible person.
- Each stallholder should ensure that they have adequate trading insurance and bring the certificate to the event. Traders without such a certificate will not be allowed to trade at this event.
- Stall holder are responsible for their own overnight security
- Stallholders must remove all items and refuse all from their stand at the close of trading; failure to do so will result in an additional clearance charge.
- The promoters of the Artemis Gathering will not be held responsible for any accident, damage or loss however caused that may occur to any Exhibitor, articles or property brought on to the site during the event. The said Organisers will not be responsible for any actions or expenses on account of, or in respect of any damage or injury caused.
