## Trader's information – Witchfest International 2023

Dear Trader,

Thank you for your request for information about booking a stall at Witchfest International in Croydon on Saturday the 18th of November. We expect to sell approximately 3,000 tickets for this event, with over 40 speakers attending and many other events happening throughout the day it should be a fantastic opportunity for all traders to promote their products.

Stalls will be allocated on a first come first served basis within your trading category, it is important to fill out the form carefully summarising your products. Please ensure you return the completed form promptly including **copy of traders insurance** plus payment by Cheque as we cannot reserve any stalls without these details! We are asking that all stall traders donate a small prize to the raffle. If you are a full, or a gold member of the Children of Artemis you are entitled to a discount on the price of a stall – please be sure to include your membership number on the form.

Please note that each stall hall trader is allocated a total space of 6ft x 5ft including seating for the stallholder; the tables provided are 6ft x 2ft 6ins. In the stall hall custom stalls must have prior agreement in writing. For health and safety reasons we cannot permit people to obstruct walkways with lights or stands of any description.

We anticipate the loading-in time for stallholders will begin at approximately 8.30am, and must be completed by 9:45am. Trading will start when the doors open at 10:00am and trading will cease at 6pm. Further details will be sent with your confirmation letter including: directions to Fairfield Halls and all the information for the day. Your stall allocations will be given to you on the day. If you have any questions, please do not hesitate to contact us at the address or phone number on the booking form.

If your stall booking is accepted, you will be sent a confirmation letter. Only traders who have received this confirmation have a stall booking, so please ensure you have your acceptance letter before attending the event. If you have not been accepted, you will receive a letter stating you are being placed on the cancellation list.

We want a pleasant event for everyone, so please be patient and understanding, any trader who is aggressive or unreasonable with our visitors, venue or volunteer staff will not be considered for future events. We will do our best to answer your requests for power or wall spaces, but please bear in mind that these are limited, so we ask that you only make such a request if there is no other way for your stall to function.

We hope you are looking forward to this event as much as we are and look forward to meeting you all there.

- *To prevent litter within the venue, no unsolicited leaflets should be distributed anywhere within the building or grounds. Only leaflets advertising your own business, products or services can be placed on your stall without gaining the explicit permission of the Witchfest Organisers.*
- *Traders must have adequate insurance including Public Liability insurance*
- *The Children of Artemis (by its Agents and / or Witchfest Organisers) reserves the right to cancel any booking and /or refuse admission without notice. In such cases a full refund of booking / admission fee will be made. The Children of Artemis (by its Agents and / or Witchfest Organisers) does not accept responsibility for any losses, costs or expenses which may result from such cancellation or refusal.*
- *Witchfest International stall bookings are not transferable and the fee paid is not refundable except in the case of the cancellation of the event.*
- *The Children of Artemis (by its Agents and / or Witchfest Organisers) reserve the right to refuse, at its absolute discretion, any application.*
